Global Children's Center Waiver form and agreement of usage

- 1. Children must be supervised at all times! DO NOT leave children unattended!
- 2. Ensure that all children using the Inflatables understand and follow these rules.
- 3. Compatible age groups must play on the unit at the same time. Age groups must not be mixed.
- 4. Compatible sized children MUST play on the unit at the same time. Different sized children must not be mixed.
- 5. Inflatables are designed for children, not adults. No adults "playing" in the Inflatables please!
- 6. The following items are not allowed in the Inflatables, and must be remove:
 - NO Shoes or foot wear in the Inflatables
 - NO Sharp Objects in the Inflatables
 - NO Glasses in the Inflatables
 - NO Party Favors in the Inflatables
 - NO Jewelry and watches in the Inflatables
 - NO Chewing gum in the Inflatables
 - NO Hats in the Inflatables
 - NO Food or drinks in the Inflatables
- 7. NO Silly String in, around, or near the Inflatables (silly string has a chemical in it that will "eat" through the vinyl)!!!!!!!
- 8. No sitting or lying inside the Inflatables.
- 9. No flips or somersaults.
- 10. Do not bounce or play near the opening of the Inflatables.
- 11. No food or drink inside or near the Inflatables.
- 12. No running within 10 feet of the Inflatables.
- 13. Keep all pets away from Inflatables.
- 14. Keep all children away from blower and power cords (create a "keep away" zone).
- 15. Do not unplug the Inflatables while occupants / riders are inside.
- 16. Do not attempt to move or un-stake the Inflatables.
- 17. Do Not Use the Inflatables under the following conditions, or if they develop:
 - High Winds, Rain or Thunder Storms
 - Power outage
 - If Inflatables becomes wet for whatever reason
 - Inflatables are punctured.
 - o In the event of foul weather, make sure all children exit the Inflatables safely, and then deflate the Inflatables by unplugging. Cover the blower to protect from rain. Turn off all sprinklers!
- 18. If the Inflatables starts to deflate:
 - Make sure all children exit the Inflatables quickly and safely

In consideration for utilizing the Global Children's Center, the undersigned:

- 1. Agree that prior to participating, they will inspect the Inflatables and equipment to be used, and if they believe that anything is unsafe, they will immediately advise the GCC Employee of such condition (s) and refuse to participate. If I will not be present at the time the inflatable(s) will used I hereby authorize GCC staff, renters, administrators, officers, directors, agents, and other employees and volunteers to inspect the inflatables on my behalf.
- 2. Agree that parent (s) or legal guardian (s) will instruct any minor participant that prior to participating, s/he should inspect the Inflatables and equipment to be used, and if the advise the GCC Employee of such conditions and refuse.
- 3. Acknowledge & fully understand that each participant's own action, inaction, or negligence, but the actions, inactions, or negligence of others, the rules of play or the conditions of the premises or any equipment used. Further, that there may be other risks not known to us, or reasonably foreseeable at this time and assume all of the foregoing risks and accepts personal responsibility for the damages following such injury.
- 4. Intending to be legally bound, do hereby release, waive, discharge and covenant not to sue Global Children's Center or renters, administrators, officers, directors, agents and other employees and volunteers, their participants, owners and lessors of the location used to conduct the activities, all which are hereinafter referred to as "lessees" from any and all liability to each of the undersigned, his or her heirs, personal representatives, guardians, parents or other representatives, from any claims, demands, losses, or damages on account of injury, including death, or damage to property caused or alleged to be caused in whole or in party, by negligence of the release or otherwise in connection with association or participation in and/or arising out to travel to, participation in, and returning from participation with Global Children's Center
- 5. In event that the undersigned sustains injury or illness while participating on Global Children's Center employee is around to help, I hereby authorized any emergency services, first aid, medication, medical treatment or surgery deemed necessary by licensed medical personnel, or other necessary medical personnel. Also give my permission forms, or other necessary medical documents, and to act on behalf of the undersigned in the undersigned or his/her parent are not immediately available to do so.
